

BILL PAYMENT

Please continue paying your water bill until you receive a water statement showing “EFT” on the payment coupon. Although you will continue to receive water statements, your payment will be electronically deducted from your bank account 7 days after the due date shown on the water statement. From the time you sign up, it can take up to two weeks to process your application.

ABOUT ABA/ROUTING NUMBERS

These are special numbers we use to identify your bank and your account. You can get your ABA/routing number and account numbers by using the diagram on the back of this application to record the correct numbers from your check for use in completing this application.

Find Your ABA/ Routing Number

The first number you need is your bank's routing number. This number will always be the numbers between the  characters, shown below in red:

1. Complete and sign this application form.
2. Attach a voided check from your checking account or savings account. This is needed for the account number and the American Banker Association (ABA) routing number from your financial institution.

Additionally, payments returned due to insufficient funds are subject to return check fees and late payment penalties.

By authorizing Fair Oaks Water District to deduct funds from my account, I acknowledge that payment of my water bill remains my sole responsibility. I agree and understand that Fair Oaks Water District cannot be responsible for any failures of my financial institution to transfer funds, failure of mine to maintain sufficient funds in the paying account, or for any failures of transfer due to problems arising from problems in the electronic funds transfer system.

It is Fair Oaks Water District's policy to protect the integrity of its customer's financial information and records at all times. By signing below and authorizing the deduction of funds from my account, however, I agree and understand that Fair Oaks Water District has no control over the electronic funds transfer process and, therefore, cannot guarantee the security of my financial information.
