How to get your Energy Star Clothes Washer rebate

1. You must be replacing an older inefficient clothes washer with a new high efficiency and high-water factor washing machine listed. <https://www.energystar.gov/productfinder/product/certified-clothes-washers/results>
2. Contact the Fair Oaks Water District to see if rebate funds are available.
3. Purchase and install the new clothes washer. Qualifying clothes washers can be located under the EPA's Energy Star Most Efficient list at www.energystar.gov.
4. Return the original dated receipt invoice with the price, model, brand and completed application. Keep a copy for your records.
5. Submitting a signed application represents agreement to have your water provider verify installation of the clothes washer, with your accompaniment. **Fair Oaks Water District may** schedule an inspection.
6. Rebates of **\$50.00** per clothes washer and a max of 1 rebate per calendar fiscal year.
7. The water agencies issue rebates within eight to ten weeks of receipt of your completed application.

Qualifications

Only High Efficiency Clothes Washers from EPA's Energy Star High Water Factor list are eligible for rebates.

1. Purchase of a new washing machine must occur within the program period

of **January 1, 2022 to December 31, 2022.**

The number of rebates is dependent upon the availability of program funds.

2. The location of installation must be served by **FAIR OAKS WATER DISTRICT.**
3. Rebates are not available for the replacement of an existing high efficiency clothes washing machine with another new high efficiency clothes washing machine.
4. New construction is not eligible for rebate under this program.
